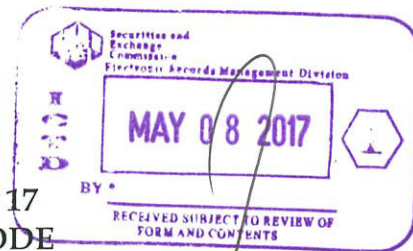


The purpose of the postponement is to provide the Board and management of Paxys with greater opportunity in determining the Company's strategic direction.
