The organization has 2 independent directors. It is compliant with the SEC and its own manual's requirement of 2 or 20% of its board of directors being independent directors.

There is no provision in the Board policies nor in the Manual regarding the term limit of Independent Directors. In any case, the company will adopt the SEC's requirement (effective January 2, 2012) of a term limit of 5 consecutive years for the independent directors with cooling off period of 2 years and no more than 2 terms or a total of 10 years. As such, our 2 Independent Directors have already served one year of their 5 year term.
